- (3) Smt. Rashmi Kulkarni, aged about 42 years, D/o Ramakanth Kulkarni, residing at 10033 Prestige Royal Gardens, Avalahalli Yelahanka, Bengaluru- 560064.

(hereinafter referred to as the Founder Trustees).

WITNESSETH AS FOLLOWS:

1. Whereas the Founders are desirous of creating a Public Charitable Trust.
2. Now these presents witnesseth as follows:
 - a. The Founders above-named hereby establish a Public Charitable Trust by the name of **Green Circle** with the objects and upon the terms and conditions hereinafter mentioned.
 - b. **Initial Trust Funds:**

The Founders have this day contributed in all a sum of Rs 25000/- (Rupees Twenty Five Thousand Only) towards the Trust Fund jointly.

3. Trust Property:

The Trust Property shall comprise of the said initial Trust Fund as well as all other amounts, securities, properties movables or immovables, which may be contributed or donated by the Founders, Members of the Public or anyone else or from any other source and shall also include all additions, accretions, and acquisitions made by the Trust and the income received by the Trust from time to time. Trust Property shall vest in the Trustees, herein upon Trust, subject to the provisions hereof for the due fulfilment of the objects of the Trust.

4. Office of the Trust:

The principle office of the Trust shall be at No. 9017, Prestige Royale Gardens, Avalahalli, Doddaballapur Road, Yelahanka Bengaluru 560064.

5. Nature of the Trust:

This Trust shall be a Public Charitable Trust having no commercial or profit motives. It shall be maintained and administered to promote environmental awareness, ecological balance in order to help create a sustainable future for the future generations, in every manner possible for the benefit future generations of India and the World at large. The benefit of this Trust shall ensure to all sections of public in India without any distinction. The Trust Property including its funds and income shall be applied solely towards promotion of the objects for which this Trust is established.

6. Objects of the Trust:

Without in any way limiting the generality of the main objects stated in para 5 above, the objects of the Trust are to do the following:

- a) To protect and conserve critical environmental resources and invaluable natural and man-made heritage which are essential for life-supporting livelihoods and welfare of the society
- b) To promote Awareness among the members, general public as well as students about the need for protecting environment.
- c) To impart ecological and environmental education by means of lectures, courses, meeting, seminars and similar programmes.
- d) To establish and maintain voluntary as well as membership-based programs, including those based upon membership through financial contributions, for the conservation and promotion of the environmental and economic wellbeing
- e) To provide sufficient opportunities and facilities to study and discuss the impact of environmental degradation and suggest measures for prevention thereof.
- f) To encourage nature conservation research and research in other fields leading to positive impact on the nature and human life

- g) To establish training and other educational establishments to impart education and initiate research studies related to biodiversity, natural resources, Environmental Protection and wildlife conservation
- h) To conduct nature camps, trekking and any other nature-related programmes to inculcate interest and love for nature, Environmental Protection and wildlife conservation.
- i) To bring out journals, books and other visual aids to promote nature and environment education.
- j) To undertake Eco-Development endeavours, nursery raising techniques, tree planting programmes, social forestry, afforestation, rainwater harvesting and similar programmes.
- k) To recommend legislative measures to appropriate authorities with regard to local, national and international environmental issues.
- l) To co-ordinate its activities with any other association or trust or other body corporate, cultural, educational or government departments to promote any one of the above-mentioned objectives.
- m) To encourage and utilize the services of resource persons to conduct programmes on nature, ecology and environment.
- n) To promote and organise students and youth clubs and conduct training courses in health, nutrition for health promotion and prevention of diseases.
- o) To create or assist in creating branches to fulfil any of the objectives detailed herein above.
- p) To receive grants, gift, donations, etc, to purchase, to take on lease or in exchange or otherwise and acquire and maintain any immovable property for the trust in India or Abroad.
- q) To raise funds through grants, loans, subscriptions, contributions, donations, gifts, royalties, income from sale of the products and also by negotiating for and receiving government or other grants in aid or in any other manner the trust may deem fit.
- r) To use all the income from the works of the Trust, where so ever derived, for the purpose fulfilling the objects of the trust in any manner that the trust deems fit.
- s) To do all such other acts and things whether incidental or ancillary to the objectives that have been enumerated above.

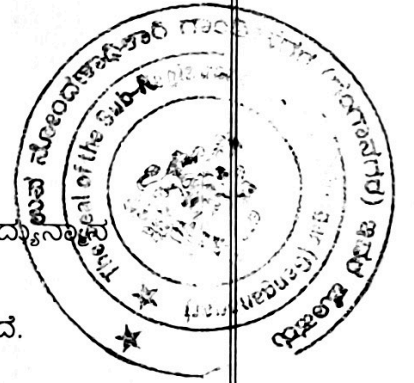

7. Management of Trust:

This Trust shall be administered by a Board of Trustees whose Number shall not be less than 3 or more than 11. The Founders shall be the permanent Trustees. The remaining shall be co-opted and/or nominated by the founder trustees. The permanent Trustees may nominate other Trustees and they will be called "Nominated Trustees". So however, the total number of trustees including both permanent Trustees and co-opted/nominated Trustees shall not exceed 11.

The Board of Trustees shall elect the Chairman, Treasurer and Secretary from among themselves once in 3 years. The routine administration of the Trust, its property and affairs, convening meetings of the Trustees, maintaining minutes, accounts, records and other documents, of the Trust shall be looked after by the Secretary of the Board of Trustees.

8. First Trustees:

The First Trustees are:

1. Sri V Selvarajan
2. Sri S L Patil
3. Smt. Rashmi Kulkarni

9. Terms of the office of the Trustees:

The term of the permanent Trustees shall be for life. The term of office in the case of nominated or co-opted Trustees, shall also be 3 years. Thereafter they will be eligible for reappointment.

10. Vacancies:

A Trustee shall cease to be in office with immediate effect on his becoming insolvent or insane or of on being convicted for any offences involving moral turpitude or at resignation or at death. Any vacancy occurring in the office of Trustees whether permanent or nominated including those caused by retirement shall be filled by

the permanent Trustees, until a trustee is nominated to that office either unanimously or with the consent of the majority. In case, the office of any of the permanent trustees is rendered vacant due to any of the reasons mentioned above, the trustees shall forthwith call a meeting of all the trustees both permanent or nominated/co-opted and thereafter nominate any one of them to occupy the office of the permanent trustees, provided that such decision shall be unanimous in nature. The existence of vacancies in the office of the Trustees shall not invalidate any act or decision by the Board of Trustees.

11. The Trustees may from time to time delegate to any one of them or to any other person or Committee, such of their powers and duties, as they deem fit, subject to, nevertheless to, their retaining the ultimate control and supervision.

12. Power of Trustee: Trustees shall have full power and authority to administer the Trust Property. The investments shall be in accordance with the provisions of Sections 11 to 13 of the Income Tax Act.

- a) To receive, collect and enforce recovery of all monies due or payable to the Trust and grant necessary receipts and discharge therefor.
- b) To appoint, terminate, suspend and otherwise deal with the employees
- c) To appeal and act before courts, tribunals, public offices, etc.
- d) To institute, prosecute and defend all suits and other legal proceedings.
- e) To incur all necessary expenses from the corpus or income of the Trust in connection with the Trust and its management and for its institutions.
- f) To apply properties and funds of the Trust for the objects of the Trust.
- g) Generally, to do all such acts, deeds and funds as may be required to fulfil the purposes of the Trust and matters incidental thereto.

13. Transaction of business by the Trustees:

The Trustees shall meet once in 3 months or as often as may be necessary for the efficient conduct of the affairs of the Trust. Such meeting shall be presided over by the Chairman of the Trust or in his absence or inability, by one of the Trustees. elected by the Trustees to be the Chairman of the meeting. The business of the Trust may also be transacted by circulation of papers. All decisions of the Trust shall be by a simple majority except as otherwise expressly provided therein. The Chairman of the meeting shall be entitled to a casting vote in the event of equality of votes at the meeting.

14. The accounts and minutes:

The Trustees shall maintain true and correct accounts of all receipts and payments and dealings in regard to the Trust property and shall also maintain the correct record of their meetings and deliberations.

15. Indemnity:

The Trustees shall be fully kept indemnified and harmless by the Trust against any action or claim, loss suffered or liability arising against them, on account of anything done by them in good faith pursuant to the powers and authority conferred on them by these presents.

16. Irrevocability/Amendments of the Trust:

The provisions of this Trust may be altered or amended by the resolution passed by the Board of Trustees either unanimously or with the consent of the 3/4th majority provided the character of this Trust as a charitable Trust for the promotion of the objects set forth above shall not be altered. This Trust is irrevocable.

18. Acceptance of the Trust:


